4. FIRST AID MEASURES

First aid measures

General

Inhalation

Skin contact

: Remove contaminated clothing and shoes. Wash skin thoroughly with soap and water or use recognized skin cleanser. Do not use solvents or thinners.

Eye contact

: Check for and remove any contact lenses. Immediately flush eyes with running water for at least 5 minutes, keeping eyelids open.

Ingestion

: If swallowed, seek medical advice immediately and show this container or label. Keep person warm and at rest. Do not induce vomiting.

5. FIRE-FIGHTING MEASURES

Extinguishing media

: Recommended: alcohol-resistant foam, CO₂, powders, water spray.

6. ACCIDENTAL RELEASE MEASURES

Due to the organic solvents content of the preparation:

Personal precautions

: Exclude sources of ignition and ventilate the area. Avoid breathing vapor or mist. Refer to protective measures listed in sections 7 and 8. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13).

Environmental precautions : Do not allow to enter drains or watercourses. If the product contaminates lakes, rivers, or sewers, inform the appropriate authorities in accordance with local regulations.

Methods for cleaning up : Preferably clean with a detergent. Avoid using solvents.

7. HANDLING AND STORAGE

Handling

: Due to the organic solvents content of the preparation: Keep container tightly closed. Keep away from heat, sparks and flame. Avoid contact with skin and eyes. Avoid the inhalation of dust, particulates, spray or mist arising from the application of this preparation. Avoid inhalation of dust from sanding. Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Put on appropriate personal protective equipment (see section 8). Never use pressure to empty. Container is not a pressure vessel. Always keep in containers made from the same material as the original one.

Storage Comply with the health and safety at work laws.
: Store in accordance with local regulations. Observe label precautions. Store between 5 and 25°C. Store in a dry, cool and well-ventilated area. Keep away from heat and direct sunlight.
Keep away from: oxidizing agents, strong alkalis, strong acids.

Exposure controls : Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction.

Occupational exposure controls

Respiratory system : If workers are exposed to spray they must use appropriate, certified respirators with filter A (brown) for organic solvent use combi filters with particle filter P2 (II b).

Skin and body : Personnel should wear antistatic clothing made of natural fibres or of high temperature resistant synthetic fibres.

Hands : Wear suitable gloves of Butyl rubber (>8 h) or nitril rubber (>4 h) EN 374 category III or accordingly to the glove suppliers recommendation.
